## 2015-2016 CROP YEAR POLICY

### STORAGE RATE

CORN: .18 TO JANUARY 1, 2016: THEN .03 EACH MONTH TO AUGUST 31, 2016  
BEANS: .20 TO JANUARY 1, 2016: THEN .04 EACH MONTH TO AUGUST 31, 2016

### PRICE LATER RATE

CORN: .18 TO JANUARY 1, 2016: THEN .03 EACH MONTH TO AUGUST 31, 2016  
BEANS: .20 TO JANUARY 1, 2016: THEN .04 EACH MONTH TO AUGUST 31, 2016

**NOTE: ALL PRICE LATER CONTRACTS MUST BE SIGNED BY THE PRODUCER THE SAME DAY THE CONTRACT IS CREATED. THIS IS A STATE LAW.**

ALL PURCHASE CONTRACTS MUST BE SIGNED AND RETURNED IN 10 DAYS.

JANUARY CHECKS WILL BE AVAILABLE ON JANUARY 4th, 2016.

ALL GRAIN WILL AUTOMATICALLY BE ROLLED INTO STORAGE 10 DAYS FROM TIME OF DELIVERY, UNLESS IT IS APPLIED TO CONTRACT (SALES OR PRICE LATER). PLEASE NOTIFY US REGARDING DISPOSITION OF YOUR GRAIN IN THIS TIME PERIOD TO AVOID MINIMUM STORAGE CHARGES.

### SHRINKAGE:

- ALL CORN SOLD WILL BE SHRUNK TO 15%
- OPEN STORAGE, WAREHOUSE RECEIPTED AND PRICE LATER CORN, WILL BE SHRUNK TO 14% MOISTURE.
- ALL CORN LOADS WILL STAND ON THEIR OWN, USING A 1.4% SHRINK FACTOR.
- AFTER DECEMBER 1<sup>ST</sup>, NO DRYING WILL BE CHARGED AND WE WILL BE USING A SHRINK FACTOR OF 2.5% PER POINT ON A DAILY AVERAGE.

ALL SOYBEANS 13.1% AND OVER WILL BE DISCOUNTED ON A LOAD BY LOAD BASIS.  
WE WILL RESERVE THE RIGHT TO REJECT BEANS OVER 16%.

**\*\*WE WILL NOT ACCEPT SPECIALITY SOYBEANS OVER 14% MOISTURE\*\***

DRYING CHARGES WILL BE DEDUCTED FROM YOUR JANUARY 2016 CHECKS.\*\* IF YOU  
HAVE NOT SETTLED GRAIN BY THEN, WE WILL BILL ANY REMAINING DRYING CHARGES  
BY THE MIDDLE OF JANUARY 2016. IF YOU WISH TO PAY YOUR DRYING BILL IN 2015,  
**PLEASE LET US KNOW BY DECEMBER 15<sup>TH</sup>.**

IN 10 DAYS.
